Rip Rap Bid from Tom Cooka - The Board reviewed a bid from Tom Cooka for adding rip-rap at 506 Blue Spruce, 912 Wilderness, 714 Foxhill and 718 Foxhill for \$490.00.

Motion made by Fred, second by Dave to approve the bid from Tom Cooka for \$490.00 for riprap installation. The Motion carried.

Lot 139 Project Request - The Board reviewed a project request from Lot 139 to widen the driveway in order to allow for adequate parking and not violate the rules. The Board agreed with the Architectural Committee's recommendation that the owner be asked to widen the mouth

of the driveway to 6 feet and taper up to 4 feet at the top. This should allow for another vehicle to enter the driveway without driving over the landscape.

No Solicitation - Dave stated that a handyman scam from "The Sullivan Brothers" has occurred in the community and more specifically at his home. These men are putting flyers on homes and then appear to be casing the neighborhood. The Board discussed different options to try to remedy this type of problem.

Motion made by Dave, second by Fred to purchase two (2) No Trespass, No Solicitation signs for both entrances to the community. The Motion carried.

AMCOR will send a sample sign to Jere Jarrell along with the proper state/town ordinance.

There being no further business, Motion made by Dave, second by Fred to adjourn the meeting. The next meeting will be held May 8, 2015.
